#### **Dear HCSD Community:**

Providing a safe learning environment for students is our number one priority. We are always asking ourselves if we are doing everything we can do to keep our children safe.

Unfortunately, tragic school events have led to heightened safety measures in schools across the nation. We are in the process of installing improved security cameras on our premises, have door locking systems with greeters on every campus, and have upgraded our public address system to insure that proper communications are in place. Periodically, we engage in drills to prepare both students and staff for emergency situations. Additionally, we have two experienced, retired police officers who serve as school safety officers at both the elementary and secondary campuses.

Our safety plans are reviewed on a regular basis and we work to build strong relationships with local law enforcement. The New York State School Board Association (NYSSBA) recently reported that, "just over 17 percent of New York State districts chose to add School Resource Officers (SRO) as the most potentially helpful measure a district could take, but more than 40 percent of those who hadn't added officers said they couldn't afford the expense" (Woodruff, 2013).

We are extremely fortunate and grateful in Hudson to have both the Columbia County Sheriff and Hudson Police Departments offering SRO services at no charge to the district. At the February 24<sup>th</sup> Board of Education meeting, Sheriff David Bartlett announced the opportunity for Hudson to split a full-time SRO with a neighboring district beginning this semester. Likewise, Chief Edward Moore of the HPD has generously offered full-time services to our district at no cost beginning next school year.

The addition of SROs is purely for proactive measures in light of our changing world. This decision is in no way an expression that our district or our neighboring districts have any imminent safety concerns internal or external in nature. In fact, with the recent drop in Hudson's overall referrals and suspensions, this is the perfect time to introduce these members of our community into our schools.

SROs are an invaluable and very welcomed resource to the school team. In addition to being good role models, they are also a friendly face and an added assurance to our students, staff and families that our schools are a safe place to learn.

The HCSD family of educators thanks our local law enforcement agencies for recognizing that our children's safety is paramount and a worthy return on the investment of their time and effort.

# Hudson City School District Prepares for PARCC Field Testing

Since 2001 all students in grades 3-8 have been required to take an annual state assessment in English Language Arts and Mathematics. Traditionally pencil-paper tests, many states across the country, including New York, are preparing to shift from the traditional to computer-based tests. The participating states have joined together to form the PARCC (Partnership for Assessment of Readiness for College and Careers) consortium. PARCC will provide ELA and math assessments to measure student progress on the Common Core State Standards and the readiness path for college and careers. These new tests are scheduled to be implemented in the 2014-15 school year.

In preparation for PARCC the Hudson City School District has a specific agenda.

#### **Technology**

-To ensure that our computers and network are ready and capable of handling large numbers of students testing at the same time in addition to our everyday traffic.

#### **Transition through Practice**

- -Students will need to make the shift from reading comprehensive passages on paper to reading them from a computer screen.
- -Hand written answers will now be typed answers. Accurate and timely key-boarding skills will replace the paper and pencil.

These skills are already being developed at the primary level and we will continue to cultivate them district wide over the years to come.

Field testing is a "hands on preview, measurement and learning tool" in regard to PARCC testing. The potential questions measure the validity of the question itself – does it actually measure the knowledge and skills it was designed to? Results will be utilized to determine if the questions are accurate and may be used on actual tests in the future. In the spring of 2014 Hudson has been asked to field test items in math and ELA. This experience will be a trial run that helps us to pinpoint the preparation areas that need work and ensure a smooth transition for our students.

Budget time is here once again and as of today, the Hudson City School District (HCSD) is facing a preliminary budget deficit of \$1,573,713. It is important to note that this is a preliminary estimate and the numbers right now are very fluid. Much information has yet to be hashed out at the State level and the District level. Many tough decisions will have to be made while we go through the budget process and the community must be involved. We feel it is imperative for members of the community to remain informed about what challenges their school district is facing. Please take the time to come out to the Hudson City School District "Community Conversations" at the John L. Edwards Primary School on March 12, 2014 and March 26, 2014 from 6 pm-7 pm.

#### 2014-2015 Tax Cap Calculation

Of course, one piece of information in the forefront of all taxpayers' minds is the tax levy. For the 2014-2015 school year, the Hudson City School District has a maximum allowable tax levy increase by law of **2.26%**. This means that unless HCSD intends to receive 60% or more voter approval, the maximum increase to the tax levy will be **2.26%** - the lowest annual increase to the tax levy since 2008-2009 representing a dollar increase of \$466,687.

#### **Gap Elimination Adjustment (GEA)**

The gap to which the title "GEA" refers is the difference between budgeted State expenditures and the revenue available to support those expenditures. Below you will see a table representing the GEA amounts specific to the Hudson City School District dating back to the 2009-2010 school year, when the GEA was known as the Deficit Reduction Assessment (DRA). If the GEA amount proposed by Governor Cuomo is enacted for 2014-2015, the HCSD would have had \$11.84 million taken back since 2009-2010! When we look back on the amount of positions that were cut and the taxes were increased over the years, this is particularly outrageous. It is time for the State to fulfill its constitutional obligation to the HCSD and eliminate the Gap Elimination Adjustment. Please aid us in our efforts to lobby our local officials and state law-makers for the elimination of the GEA immediately!



We are having an issue with students being returned to the school because no one was at the bus stop to meet them. Please remember, we work in partnership with our bus companies to safely transport your children, and we work with you to agree to either be at the bus stop to receive your children or send a designated family member or babysitter. 

#### **Junior High School Grade Promotion**

After watching too many 9<sup>th</sup> graders struggle to earn credits, the staff at Hudson JHS decided to change what was clearly a failed policy. In the spring of 2011 teachers and administrators at Hudson JHS developed a plan modeled after the New York State high school credit system – but with an important twist. In September 2011 they implemented the plan that has since changed their former 'path-of-least-resistance' into one of the most demanding middle level promotion policies in New York State.

Junior high principal Derek Reardon describes just how and why their idea was developed. "We started off with a simple goal. We wanted a promotion policy that made all classes count for credit, just like high school. We wanted it to be simple, concrete, more challenging, and most of all, teachable. We wanted to create a policy that trained students how to successfully navigate the 22 credit high school graduation requirement - before they got there. We knew that for this idea to work, for it to be teachable, that we would have to award credits long before the school year ended. Awarding credits every 10 weeks is the key feature as we wanted short-term credit goals to help students stay focused and motivated. In putting this fairly radical policy into place, we've experienced nearly unanimous support from teachers, administrators, and parents. We realize there are no instant solutions, but after three years of implementation, we wouldn't dream of going back to our old policy that was essentially a free ride for students."

#### The Future of HJHS Students and the Common Core Standards.....

Amid the commotion and controversy swirling around the implementation of the new Common Core standards and the related testing, 7<sup>th</sup> and 8<sup>th</sup> grade students at Hudson JHS are quietly experiencing an engaging, innovative, and game-changing approach to learning. The staff at Hudson JHS have been implementing the new program and it has transformed the school climate, dramatically improved student attitudes and efforts in their classrooms, and has produced a quantum leap forward in terms of preparing 8<sup>th</sup> graders for the rigors of high school.

Guidance counselor Rosalie Cornell sums it all up: "Students have responded big time. They buy into it because the rationale makes sense to them, the credit requirements are demanding but doable, and the rewards [credits] are tangible – and timely. This program has exceeded even our wildest expectations. In fact, the policy is working so well that we are considering ramping up the credit requirements for next year. Our students have demonstrated that when the stakes are high enough and the goal seems attainable, they will rise to the occasion."




